What is the overall deductible ?	\$0/person or \$0/family for In- Network Providers . \$500/person or \$1,000/family for Non- Network Providers .	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the policy, the overall family deductible must be met before the plan begins to pay.
Are there services covered before you meet your deductible ?	Yes. Vision for Non- Network Providers .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	Yes. \$150/person or \$300/family for Prescription Drugs In-Network Providers . There are no other specific deductibles . What is the out-of-pocket limit for this plan ?	\$2,500/person or \$5,000/family for In- Network Providers . \$4,000/person or \$8,000/family for Non- Network Providers .
